

**EXERCISE OF OPTION FOR WAIT LISTED CANDIDATES OF ASM, CATG.7 OF CEN  
NO.03/2012**

Sub: Consideration of candidature for East Central Railway and Northeast Frontier Railway.

Candidates who were called for verification of documents for the post of Assistant Station Master, Catg. No. 7 of CEN 03/2012 as wait listed candidates are advised to exercise the attached option within the stipulated date.

The clause No.13.07 of the Centralised Employment Notice No.03/2012 states "candidates finally selected are liable to be posted anywhere on Indian Railways, if required."

In terms of the above clause and Railway Boards recent directives, names of above wait listed candidate of ASM will now be considered for empanelment in East Central Railway or Northeast Frontier Railway for the same.

In case any candidate wants to refuse the above and stay in the wait list of this RRB knowing very well that he/she may have to wait for a long time for any vacancy as and when arises or may not be empanelled at all, where as candidates of lower rank may be empanelled before him/her in East Central Railway or Northeast Frontier Railway, he/she may submit such refusal by 22.08.2015 to this RRB office. If nothing is heard from a candidate within the stipulated period, this offer will be treated as final. It will be presumed that he/she has opted for East Central Railway or Northeast Frontier Railway. In case his/her name is considered for East Central Railway or Northeast Frontier Railway, his/her name will be deleted from the wait list of this RRB.

The option should reach this office before 22.08.2015 in the prescribed proforma enclosed wherein candidate should clearly indicate his/her acceptance or refusal.
